TIMETABLE

March 31, 2019	Deadline for submitting candidates for nomination
On or before April 22, 2019	Candidates' list and their profiles sent to all ordinary members.
April 30, 2019	Election at Annual General Meeting, venue to be advised.

Nominees will be evaluated on the following criterias:

- The nominee must have been an Association's Ordinary Member for one year prior to the beginning of the term of office. Other member categories are not eligible to run for the election.
- The nominee must be in good standing and have paid the membership fee for year 2018.
- The nominee is not currently under lawsuit, no record of imprisonment nor bankrupt.



Individuals who want to run for office should fill in the "Personal Profile" form and submit to TSPA office on or before April 7, 2019

**Executive Board Officer Descriptions
(two-year terms)**

- (1) **President:** The President shall be the chief executive officer of the Association to ensure the running of the association is in line with the Constitution and the rules and regulations for the transaction of the business of the Association, and has been designated by the Board of Directors to conduct the business of the Association with outsiders. The President shall preside at all meetings of the Board of Directors as well as at the General Meetings.
- (2) **Vice Presidents:** The Vice Presidents' duty shall be to assist the President in all matters within the capacity of the President's powers and duties and shall perform the duties in place of the President in his or her absence or disability.
- (3) **Secretary:** The Secretary shall handle all the correspondence, keep all documents of the Association and record all the proceedings of the Board of Directors' meetings and the General Meetings, and shall perform such other duties as may be prescribed by the Board of Directors.
- (4) **Treasurer:** The Treasurer's duty shall be to look after and disburse the funds of the Association. He or she shall keep the financial books and look after and disburse from the stores of the Association and shall perform such other duties as may be prescribed by the Board of Directors.
